Your data may be communicated externally to persons appointed as data controllers to carry out the service and to people who have an interest in it pursuant to Law 241/1990 and s.m.i. and for the fulfilment of advertising obligations, transparency and dissemination of information by public administrations in accordance with Legislative Decree 33/2013. Your data may be communicated to other administrations as required by current legislation. The declarant may exercise the rights referred to in art. 15 and ss. of Reg.
